

## SUMMARY

This conference is meant to create value for society through the professional organization of the conference: it facilitates learning by doing for building a fair and sustainable future, seconded by scientific analysis and feed-back, and it creates the infrastructure for continuous linking and learning in different geographical areas and thematic fields. By doing so the objective is to discuss how to accelerate the emergence of fair and sustainable societies and to avoid unnecessary loss of social, economic, cultural, natural, physical, financial, democratic, technological, knowledge and human capital.

The Netherlands as the host country, Fryslân as part of The North of the Netherlands as the host region and Leeuwarden as the host city are deliberately proposed because they may 'embody' the opportunities for emerging responsible economic systems, in easy connection with other regions throughout the world by its specific history, culture and aspiration for the future.

NHL Stenden | University of Applied Sciences Leeuwarden, WETSUS - European Centre of Excellence for Sustainable Water Technology Leeuwarden and the Hanzehogeschool | University of Applied Sciences Groningen collaborate to host the 3rd International Scientific Conference (ECG-IC III 2024).

The initiators create, in close collaboration with ECG International, an ethical and entrepreneurial concept for the organization of ECG-IC III 2024. The objective of this concept is to be able to capitalize on the findings of the previous ECG International Scientific conferences and to facilitate to effectively use the results and experience of ECG-IC III 2024 for the organization of the ECG-IC IV in 2026.

We intend to invite other scientific institutions to organize parallel to the ECG-IC 2024 conference so-called satellite conferences, following the same structure and themes of ECG-IC 2024 to localize learning spaces in the own language, enhance results, minimize costs, and reduce CO2-emission. This can be in Amsterdam, Utrecht, Eindhoven to cover the Netherlands more broadly, as well as Barcelona, Munich, and London to cover different language areas.

Finally, we build connections with so-called expedition conferences, which may precede the ECG-IC III 2024 or follow the ECG-IC III 2024 later in specific geographical areas, such as this time in Fryslân or around the satellite conferences. In this way specific areas will be enforced to work structurally towards the establishment of 'Living Labs' and strengthening of responsible economic systems anywhere in the world.

The title Transform! Emergence and strengthening of responsible economic systems for a fair and sustainable future underscores the urgency to identify the inhibiting factors as well as the qualities and characteristics of practices and conditions that are required to nurture the emergence of responsible economic systems.

This core question of the conference: How to strengthen emerging responsible economic systems for a fair and sustainable future?

The themes of the conference are organised around (1) Concrete domains, such as fair and sustainable water & energy systems; (2) Transformation: Territory, ownership, governance and (3) **Responsible use of** social, economic, cultural, technological, financial, physical, natural and knowledge, democratic, and human capital.

Day one sets the stage with scientific contributions on responsible economic systems and analysis of concrete domains; **Day two** provides space for contributions from social and entrepreneurial initiatives to create responsible practices and the expression of their needs for a facilitating political, financial, and juridical environment; **Day three** concludes with transdisciplinary analyses for the emergence of responsible systems and take aways by key-note listeners, politicians and follow up.

We envisage to get the following results out of this conference: (1) Conference proceedings in writing and on video, posted on the website; (2) Publications in scientific journals, started by the conference. (3) A manifesto, undersigned by scientists, civic organizations and entrepreneurs, containing a roadmap for the peaceful transformation towards a fair and sustainable future,


(4) Potentially topic- specific roadmaps, such as a roadmap towards future water systems.

(5) Potentially action agendas for participating regions; (6) Positioning of Fryslân as a permanent Living Lab; (7) Action plan for tool-development for ECG International. (8) Manual for ECG international scientific conferences in the future

With this conference we aim to create space for the voice that is not heard sufficiently: the voice of the youth and the future generations, the voice of everybody in their superdiversity, the voice of the area. What does the area and the communities that live in that area need to flourish in peace and health?

We highly value cooperation with the ECG International scientific hub, Communication hub, Consultants hub and Speakers hub, cooperation with potential satellite conferences, as well as learning from experiences from the first and the second ECG scientific conferences for the elaboration of this declaration of interest.

All names mentioned in this Declaration of Interest are tentative.

## 1. HOST COUNTRY AND REGION





### THE NETHERLANDS AS THE HOST COUNTRY

The Netherlands – the low countries – are a delta of the river Rhine, Maas, Schelde and Eems. Given the challenges of climate change The Netherlands has to reinvent itself to anticipate for the future. Possibly not coincidentally, The Netherlands is preparing for a revision of the Environment and Planning Law (2024). This new law is said to be the largest change in the legal framework since the revision of constitutional law in 1848. This law is a framework law which creates legal space for all actors in society to collaborate for building a fair and sustainable future. Yet, how the political, social and physical space that will be created by this law can be used effectively is yet to be discovered. The exercise includes the reinvention of democracy, starting from the perspective of spatial development. This is aligned with the broad international movements to create a well-being economy and to strive

for 'broad prosperity'. The 'How To' question is the key question to seize this opportunity. Therefore, we are proud to present this declaration of interest to host the 3rd International Scientific Conference for the ECG. We hope to contribute from this fertile ground and open space for thinking and doing to the strengthening of the Economy for the Common Good movement.

### FRYSLÂN | THE NORTH OF THE NETHERLANDS AS THE HOST REGION

Fryslân is a province in the North of the Netherlands: a rural area with a low population density and originally a wonderful nature. A part of Fryslân is also known as the Amsterdam Lake district. Unfortunately, Fryslân is experiencing as many regions in the world a significant decrease of biodiversity. In Groningen, the adjacent northern province, there have been significant damages to houses, infrastructure and the environment due to

earthquakes over the last decennia as a consequence of gas extraction in that area. A recent parliamentary inquiry revealed systemic failures in the governance of the area, with an enormous impact on the wellbeing of the people living in that area. There is also good news. Fryslân is known for 'The Frysian Paradox' - more happiness with less money. In Fryslân the fair and sustainable future the world is longing for, is part of the Frysian culture. To understand the economy as 'oikonomia', economy as 'household economics', as Christian Felber has put it, is culturally a 'no-brainer' for the Frysians. From the perspective of Fryslân the question is not to rush and 'catch up' with the urban areas in the Netherlands, but to share its wisdom of freedom and happiness with the world, as soon as the world is ready to receive the offer. Together we can find our new destination. Fryslân is not an idyllic place without problems, but an area with challenges and opportunities and a growing consciousness and involvement of the local population

and local entrepreneurs to search for enduring solutions. The time is right for further action through collaboration: Fryslân is preparing for the Green Deal | Fit for 55 and strives to be the most Circular EU Region in 2025.

### LEEUWARDEN AS THE HOST CITY

NHL Stenden Leeuwarden, the WETSUS institute and the Hanzehogeschool Groningen will collaborate in order to host the conference in Leeuwarden. Leeuwarden has been the Cultural Capital of Europe in 2018. This small city has a deep culture and history of linking the local to the global.

The Academy Economics & Logistics wants to develop new programs for non-financial integrated reporting as the Economy for the Common Good. Wetsus is a scientific research institute for trend-setting knowhow development for Sustainable Water Technology. The Dutch government has appointed Wetsus the status of 'national institute for strategically important research'. Wetsus organizes a multidisciplinary PhD program; some sixty PhD-researchers from over 20 universities (over 50 research chairs) are seconded in the Wetsus laboratory. ## **3. CONFERENCE THEME**

### TITLE: TRANSFORM!

Emergence and strengthening of responsible economic systems for a fair and sustainable future

ECG-IC 24

For the emergence and strengthening of responsible (economic) systems we envisage the transformation from predominantly short term, profit driven economics systems to long term value driven systems to support integrated, fair, and sustainable and scalable area development. Therefore, we need to create space for the emergence of responsible economic systems, and we need to strengthen them.

### TRANSFORMATION

The emergence and strengthening of responsible economic systems requires awareness, action, and integral system design. We consider three levels of transformation:

- I The personal level, in all our multiple identities (Inner Development Goals, consciousness, eco-versus egocentricity)
- WE The collective level:
  - 1. The interaction of all forms of organization: communities & civic organizations, government, companies, knowledge institutions, financial institutions
  - Values and definition of what is 'just' and 'good' 2.
  - 3. Existing inhibiting structures must be transformed into supportive structures
- IT The systems we design to support the mutual interaction between all forms of organizations and the individual

Four key conditions for emerging responsible economic systems were formulated by Christian Felber, during the 2nd international scientific conference of the Economy for the Common Good (ECG-IC 22 Valencia Spain):

- Economics should offer a clear definition of 'economy' (and 'economics') 1.
- Economics should be clear about the goal of the 'economy' (and 'economics') 2.
- 3. Economics should offer consistent metrics for success measurement (macro, meso, micro)
- The creation of proper metrics is a **political task**, possibly of all citizens 4.

### **CORE QUESTION:**

This core question of the conference: How to strengthen emerging responsible economic systems for a fair and sustainable future?







## 11. SATELLITE Conferences

### **IDEA SATELLITE CONFERENCES**

Simultaneously smaller 'satellite conferences' take place in other places all, potentially over the World. We invite other scientific institutions to organize simultaneous a local conference with the same set-up as the ECG-IC III 2024. to localize learning spaces in the own language, enhance results, minimize costs, and reduce CO2-emission. This can be in The Netherlands, as well as in Barcelona, Munich, London or other places around the world to cover different language areas. Scientific institutions that intend to organize a satellite conference will take care of the funding for this conference independently from the ECG-IC III 2024.

### **IDEA EXPEDITION CONFERENCES**

Potentially conferences prior to or following the ECG-IC III 2024 conference in a specific area can use the ECG-IC III 2024 concept. For example, in Fryslân or in the areas of the satellite conferences, there are possibilities to connect with other events with the same mission to build a fair and sustainable future. Thematic connections are also possible.

In case Scientific institutions want to organise an event in anticipation of the ECG-IC III 2024 conference or as a follow-up, and they will use the same concept, objectives, and themes, this may eventually add up to the establishment of an 'Living Lab' in that area, as part of the Expedition Sustainable Future towards a fair and sustainable future. In this way the ECG-IC III 2024 may potentially have much greater and sustained impact and may contribute significantly to the acceleration of the emergence and strengthening of responsible economic systems.

Scientific institutions that intend to organize a satellite conference in connection with the ECG-IC III 2024 will take care of the funding for this conference independently from the ECG-IC III 2024.

# **19. IDEA BEHIND THE ORGANISATION OF THE CONFERENCE**

We see this conference as the follow up of the first and second international scientific ECG conference and the predecessor of the fourth international ECG conference. But we see this conference also as part of broader series of thematically or geographically specific conferences, as part of a movement that builds the foundations of a fair and sustainable society.

The initiator of the conference, Jacqueline Hofstede, is motivated by the idea to shape favorable conditions for this broader movement, which she calls the Expedition Sustainable Future. The set-up of this conference is meant to create value for society through the professional organization of the conference: it facilitates learning by doing for building a fair and sustainable future, seconded by scientific analysis and feed-back, and creates the infrastructure for continuous linking and learning in different geographical areas and thematic fields.

By doing so the objective is to accelerate the emergence of a fair and sustainable society and to avoid unnecessary loss of social, economic, cultural, natural, physical, financial, political and human capital. It this way the conference aims to create space for the voice that is not heard sufficiently: the voice of the youth and the future generations, the voice of everybody in their superdiversity, the voice of the area. What does the area and the communities that live in that area need to flourish in peace and health?

Jacqueline Hofstede finds her fellow player in Elly Rijnierse, who aims to create space for a new social contract, based on human rights, especially the social, economic, cultural, and collective rights. During the 1st International Scientific conference for the Economy for the Common Good in Bremen she presented her article 'Living up to a Universal Social Contract'. This conference is meant to create an enabling environment to realize this idea.

The Expedition Sustainable Future, which is driven by 'good ancestry', by the need to identify where we collectively want to arrive rather than by avoiding risks, intends to inspire an international network of people to pave the way together for a fair and sustainable future. From this perspective she considers the ECG-IC 2024 as a logical part of the Expedition Sustainable Future.
